### SCCLA IN-PERSON EVENT PROTOCOL

SCCLA is mindful of the range of comfort levels of our guests and seeks to provide a comfortable and safe environment. Please review the below protocol, which is **required** for attendance at this event.

By checking this box, I hereby attest that I am fully vaccinated, agree to present evidence of my fully vaccinated status, and agree to adhere to the following protocol and the statements contained therein:

#### 1. Proof of Vaccination Requirement

#### I am fully vaccinated.

Upon arrival, I agree to present evidence of my fully vaccinated status (via my physical vaccination card (or a photograph thereof) or the Digital COVID-19 Vaccine Record, obtainable at https://myvaccinerecord.cdph.ca.gov/).

Guests are considered "fully vaccinated" for COVID-19: two weeks or more after they have received the second dose in a 2-dose series (Pfizer-BioNTech or Moderna), or two weeks or more after they have received a single-dose vaccine (Johnson and Johnson [J&J]/Janssen).

#### 2. Mask Requirement

I agree to wear a face mask unless actively eating or drinking, subject to applicable legal exemptions (e.g., to communicate with someone who is hearing impaired or where a face covering poses a safety risk).

The following are prohibited: masks with exhalation valves; masks made of loosely woven fabrics; scarves, buffs, bandanas, gaiters, and face shields alone.

All guests must wear masks properly covering both noses and mouths.

## 3. Self-attestation

By attending the event, I hereby self-attest that:

- (1) I am currently not experiencing any COVID-19 symptoms, and
- (2) I have not been in close contact with someone diagnosed or medically suspected to have COVID-19 in the 14 days prior to the event.

"COVID-19 symptoms" include: fever of 100.4 degrees Fahrenheit or higher, chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, or diarrhea, unless a licensed health care professional determines the person's symptoms were caused by a known condition other than COVID-19.

A "close contact" is someone who was within 6 feet of the infected person for at least 15 minutes at any time beginning 48 hours before the infected person had symptoms or tested positive. Close contacts include people who had 15 minutes of continuous contact with the infected person, as well as people who had repeated short-duration interactions with the infected person.

I agree to follow all CDC, state, and local guidelines and agree to subject myself to additional protocol that may be provided or required at the event, e.g., temperature check, social distancing, etc.

# 4. Mandatory Compliance

Adherence to the above requirements is mandatory.

SCCLA will deny entry, without refund, to any guests who are unable to satisfy the required attestation and requirements.
